PPD at Sixty-seventh World Health Assembly:

PPD attend in the Sixty-seventh World Health Assembly (WHA) held in Geneva from 19 to 24 May, 2014 to contribute in the ongoing debate, dialogue and discussion on health, specially in sexual reproductive health . PPD's presence in the assembly was significant this year because PPD represented its delegation in the full capacity of an Intergovernmental Organization for the first time after establishment of PPD permanent delegation in Geneva with full diplomatic privileges and immunities accorded by the Government of Switzerland. PPD leadership also met with Swiss SIDA, WHO Director-General, UNAIDS Executive Director, a few leading diplomatic missions and multilateral development organizations based in Geneva. Dr. Joe Thomas, Executive Director of PPD lead the delegation.

As the immediate response to PPD's advocacy, a small committee was formulated who will act as a working to find out the possibilities how the shared recommendations could be translated into policy and recommend it to the Government.
